### **NEW HAVEN ROAD CLOSURE SOUTH OF PINE ISLAND TO 125<sup>th</sup> STREET**

The City of Pine Island wants to advise residents that the New Haven Township Board has elected to close a portion of New Haven Road south of the Pine Island City Limits to the intersection of 125<sup>th</sup> Street which is under construction. The City has objected to this road closure. Although the Township has sole authority over this road, it will effectively limit access to the School and most assuredly cause inconvenience with transporting children to and from school.

Should anyone wish to express concerns or complaints regarding this issue, the City will provide contact information for a number of state and local elected officials as well as public safety and traffic officials who may be able to influence the Township Board to reconsider this action.
